

## **WiFi User Agreement**

about the use of an Internet access via WiFi in the holiday home “Villa Eviva ” with the hosts / owners: Tina Laser and Marcel Müller

### **1. Permission to share a WIFI**

The hosts operate an Internet connection via WIFI in their holiday home. The access allows the guest to share the WIFI access to the Internet for the duration of their stay in the holiday home. The shared use is a service provided by the owners and can be revoked at any time. The guest does not have the right to allow third parties to use the WIFI.

The owners do not guarantee the actual availability, suitability or reliability of the Internet access for any purpose. They are entitled at any time to stop the operation of the WIFI in whole, in part or temporarily, to admit additional users and to restrict or exclude the guest's access in whole, in part or temporarily. The owners reserve the right , in particular, to block access to certain sites or services via the WIFI at their own discretion and at any time (e.g. sites that glorify violence, pornography **or charge for services** ).

### **2. Access data**

Use is achieved by entering a password. The access data (password) is intended for the personal use of the guest only and may not be passed on to third parties under any circumstances. The guest undertakes to keep his access data secret. The owners have the right to change the access data at any time.

### **3. Dangers of WIFI use, limitation of liability**

The guest is advised that the WIFI only provides access to the Internet; virus protection and a firewall are not available. The data traffic generated using the WIFI is unencrypted. The data may therefore be viewed by third parties. The owners expressly point out that there is a risk that malware (e.g. viruses, Trojans, worms, etc.) may reach the end device when using the WIFI.

The use of the WIFI is at the guest's own risk. The host assumes no liability for damage to the guest's PC caused by the use of the Internet access, unless the damage was caused intentionally or through gross negligence by the host.

### **4. Liability and indemnity from claims**

is responsible for the data transmitted via WIFI, the paid services used through it and the legal transactions carried out . If the guest visits paid websites or enters into liabilities, the resulting costs must be borne by him.

He is obliged to comply with the applicable law when using the WIFI. In particular, he will:

- not to use the WIFI to access or distribute immoral or illegal content;
- do not illegally reproduce, distribute or make available any copyrighted material;
- observe the applicable youth protection regulations;
- do not send or distribute any harassing, defamatory or threatening content;
- do not use the WIFI to send mass messages (spam) and/or other forms of unauthorized advertising.

The guest releases the owner Tina Laser and Marcel Müller from all damages and claims by third parties that are based on an unlawful use of the WIFI by the guest and/or a violation of this agreement, this also extends to costs and expenses associated with the use or defense against such claims.

If the guest recognizes or should recognize that such a violation of law and/or such a violation exists or is imminent, he shall inform the owner of this fact.

By signing the rental agreement, the tenant accepts the terms of use listed here.
